Purpose of the Role

The Deputy Pre-School Leader supports the Pre-School Leader in the effective day-to-day running of Stepping Stones Pre-School. They help ensure a safe, stimulating and nurturing environment for all children, in line with the Early

Years Foundation Stage (EYFS). The role involves leading staff, supporting curriculum planning, maintaining high-quality practice and stepping into the Leader's responsibilities when required.

Key Responsibilities

Leadership & Management

- Support the Pre-School Leader in overseeing the daily operations of the setting.
- Lead the team in the Leader's absence, ensuring smooth running and adherence to policies.
- Act as a positive role model, promoting high standards of practice, safeguarding and professionalism.
- Assist with staff supervision, mentoring, induction and ongoing professional development.
- To support the leader in maintaining the Christian ethos of the setting.
- To attend staff meetings as required (half termly evening agenda meetings).
- To be willing to undertake preparation work outside of normal working times when necessary.
- To maintain and develop professional qualification through attending appropriate training as requested by the manager.

Curriculum & Learning

- Lead the planning, delivery and evaluation of a high-quality EYFS curriculum.
- To assist in the setting up and clearing away of all activities and equipment.
- Ensure all learning experiences reflect the pre-school's values, ethos, and commitment to child-centred play.
- Be responsible for a group of children as a key person.

- To be responsible for observing, recording and assessing as required in the Early Years Foundation Stage (EYFS) framework.
- Prepare and complete two year checks, parents consultations and annual reports for those children in your key group.
- Promote inclusive practice and ensure the needs of all children, including those with Special Educational Needs are supported.
- Assist leader with the responsibilities of the SENDCO role.

Safeguarding & Welfare

- Uphold and promote Stepping Stones' safeguarding policies and procedures.
- Work closely with the Designated Safeguarding Lead and act as Deputy DSL if required.
- Ensure the environment is safe, clean and risk-assessed.
- Support the leader in the completion of health and safety risk assessment and audits.
- Build supportive relationships with children, families and external agencies.

Operational Duties

- Assist with administrative tasks such as record keeping, communication with parents and updating documentation.
- Support with preparing resources, organising activities and maintaining a welcoming environment.
- Contribute to inspections, audits and continuous improvement plans.
- Help organise events, special activities and parent engagement opportunities.
- Be responsible for the management of petty cash.

Person Specification

Essential

- Level 3 Early Years qualification (or higher).
- Strong understanding of EYFS, safeguarding procedures and early childhood development.
- Ability to lead, motivate and support a team.
- Excellent communication and interpersonal skills.
- To have a caring, patient and enthusiastic approach.

Desirable

- Previous experience in a senior or supervisory role.
- Experience working in an early years setting.
- Paediatric First Aid qualification.
- Safeguarding/DSL training.
- Experience working with SEND children and external agencies.
